



Contest Rules

Classical Spree 2019 Contest

1. Contest Period

The Classical Spree 2019 Contest is held by the Orchestre symphonique de Montréal (hereinafter referred to as the “Contest Organizers”). This Contest conducted in Quebec (Canada), starts on Thursday, May 2, 2019, at noon, and ends on Wednesday, July 31, 2019, at 11:59 p.m. (hereinafter referred to as the “Contest Period”).

2. Eligibility

- 2.1. This contest is open to residents of the province of Quebec aged 18 and over who have purchased tickets to two or more Classical Spree concerts to be given from August 7 to 11, 2019 (see 2.2.) via the OSM ticket office (in person, by phone or online). This Contest is subject to all applicable federal, provincial and municipal laws and regulations.

Employees, agents and/or representatives of the Contest Organizers, its affiliated companies, advertising and promotional agencies, participating merchants, suppliers of prizes, materials and services related to the Contest, as well as members of their immediate families (brothers, sisters, children, father, mother), their legal or common-law spouses, and all persons with whom such employees, agents and/or representatives are domiciled may not enter the Contest.

- 2.2. Persons considered to have “purchased two or more tickets to Classical Spree concerts” and who are eligible to enter the contest must meet the following criteria and conditions:
- 2.2.1. Have purchased two or more tickets to Classical Spree 2019 concerts presented by the Orchestre symphonique de Montréal, between May 2, 2019, and July 31, 2019, at 11:59 p.m. (EDT, Montreal time);
 - 2.2.2. To be eligible, entrants must have purchased a minimum of one (1) ticket for two (2) concerts;
 - 2.2.3. All concerts that are part of the Classical Spree’s paid programming qualify;
 - 2.2.4. Tickets must be purchased through the Orchestre symphonique de Montréal customer service and ticket office, either online, in person or by phone;
 - 2.2.5. For online purchases, all concert tickets must be purchased together as part of the same transaction;
 - 2.2.6. Any person wishing to participate in the Contest without purchasing two or more tickets to OSM Classical Spree concerts can do so by sending a letter explaining, in 500 words, why they want to win the prize, to the offices of the Orchestre symphonique de Montréal, the Contest Organizers, located at 1600 Saint-Urbain Street, Montreal, Quebec, H2X 0S1. To be eligible for the Contest, participants must submit their letters no later than Wednesday, July 31, 2019, at 5:00 p.m. EDT.

3. Prize

Contest participants are entered for a chance to win special admission to attend a free major event, to which admission may not be purchased and is granted by invitation only or by winning this draw.

3.1. Prize Description

- Two (2) admissions to the VIP section at the free Grand Opening Concert presented on the Esplanade at the Olympic Park (Stadium)
 - To (2) admissions to VVIP lounge after the concert to enjoy a cocktail and an exclusive encounter with Maestro Kent Nagano.
- 3.1.1. Prize winners will be randomly selected from among all persons entered in the contest before July 31, 11:59 p.m., with a total of ten (10) prizes awarded to winning participants, who may be accompanied by a guest of their choice.
- 3.1.2. Prizes must be accepted as awarded and may not be assigned, transferred or exchanged for money. See paragraph 6.1 of these Rules.
- 3.1.3. The Contest Organizers reserve the right, at their sole discretion, to exchange the prize for a prize of equal or greater value if the prize, as described, cannot be awarded for any reason.
- 3.1.4. If a prize winner is unable to accept the prize as awarded or to make himself/herself available at the set date and time, the Contest Organizers, or any party involved, shall not provide any compensation or substitute prize.
- 3.1.5. If a prize-winner does not redeem one of the components of the prize, they forfeit it without compensation.

4. Draw and Prize Claim

4.1. Draw

A draw will be held on Thursday, August 1, 2019, at 12 p.m. EDT. Ten (10) potential winners will be drawn at random from among all eligible participants who have met the criteria and conditions outlined in paragraph 2.2.

- 4.2. The draw will be held at the offices of the Orchestre symphonique de Montréal, the Contest Organizers, located at 1600 Saint-Urbain Street, Montreal, Quebec, H2X 0S1 from among all eligible participants registered during the Contest Period.
- 4.3. The Contest Organizers will communicate via Facebook messaging and/or telephone and/or email, based on the contact information provided by the selected individuals. The ten (10) people declared as the winners will then be given instructions for claiming their prize.
- 4.4. To be declared a winner, a person whose entry is drawn must be eligible to participate in the Contest under Section 2 of these rules. This person will also have to correctly answer a

mathematical skill-testing question. If no winner is identified within five (5) days of the draw, the Contest Organizers may cancel the prize.

- 4.5. If, after making all reasonable efforts, the Contest Organizers are unable to contact a person whose name has been randomly drawn within two (2) business days of the draw, that person will be disqualified and the Contest Organizers will proceed with the selection of another entry until a new winner is identified.
- 4.6. The selection is based on random chance. Odds of winning depend on the number of eligible entries.

5. Limit of Liability

- 5.1. In order to be declared a winner, a selected entrant will be required to sign, within the prescribed time period, a Declaration of Compliance with the Contest Rules as well as a liability waiver releasing and holding harmless the Contest Organizer, its advertising and promotional agencies and supervisory body, prize suppliers and their affiliates, as well as all of their respective directors, officers, owners, partners, employees, mandataries, agents, dealers, representatives, successors and assigns from any liability for any damages of any nature whatsoever that they may suffer or that may result from the acceptance or use of this prize.
- 5.2. By accepting a prize, winners consent to the use of their name, voice, photographs, statements, place of residence for publicity, advertising or informational purposes in any medium or format without further compensation or notice.

6. General Conditions

- 6.1. Prizes must be accepted as awarded and may not, in whole or in part, be substituted for another prize, transferred to another person or exchanged for cash, except as provided in the following section. In the event that the Contest Organizers are unable to award the prize described in these Contest Rules, they reserve the right to award a prize of the same nature and of equivalent value.
- 6.2. The Contest Organizers assume no responsibility for failure of the internet or the website during the promotional period, for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, access providers, computer equipment, software, failure of any email or traffic congestion on the internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from playing or downloading any material in the promotion. Any attempt to deliberately damage any web site or to undermine the legitimate operation of this promotion is a violation of criminal and civil laws. Should such an attempt be made, Contest Organizers reserve the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
- 6.3. The Contest Organizers disclaim all liability for any damages or loss that may be caused, directly or indirectly, in whole or in part, by the download of any software or online forms or by the transmission of any information related to entering this Contest.

- 6.4. This Contest is subject to all applicable federal, provincial and municipal laws and regulations.
- 6.5. The Contest is organized in accordance with the Rules as outlined herein. Entrants will be deemed to have read and understood these Contest Rules. The terms of this contest, as set out in these rules, are not subject to amendment or counter-offer, except as provided in these Rules.

7. Régie des alcools, des courses et des jeux du Québec

- 7.1. Subject to the approval of the Régie des alcools, des courses et des jeux du Québec, the Contest Organizers reserve the right, at their sole discretion, to cancel, terminate or suspend this Contest in the event of a virus, computer bug, unauthorized human intervention or any other cause beyond the control of the Contest Organizers that may affect the administration, security, impartiality or conduct of the Contest.
- 7.2. Any litigation respecting the organization or conduct of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux du Québec for a ruling. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.
- 7.3. Any decision of the Contest Organizers or their representatives is final and without appeal, subject to any decision of the Régie des alcools, des courses et des jeux du Québec.
- 7.4. A Declaration of Compliance must also be signed by the winner's guest.
